# Presentation by Truro & District Slo Pitch Association

Mr. Cameron thanked the Commission for allowing Slo Pitch to make a presentation this evening. The Slo Pitch Association has several concerns that they wanted to bring to the attention of the Village Commission.

First and foremost, the Association would like to reemphasize their previous request for some sort of play equipment or a play area at the Airport Fields. Because of the large number of players and teams playing at any one time at these fields, there are often many children in attendance that would benefit from any play equipment or a play area that the Village might be able to supply as a positive addition to the Airport Field area.

Secondly, the Association is again asking for dugouts on fields 4 and 5. Field 6 does have dugouts that were paid for by the Slo Pitch Association several years ago.

Thirdly, the Association would like to see a chain link fence erected down the foul lines of each field.

Lastly, the Association expressed concern about the quality of the dragging of the fields at the Airport Field.

The Slo Pitch Association has approximately 200-250 people participating and over the past 10 years have paid approximately \$59,000 in yearly fees to the Village. They feel that the addition of a play area and dugouts would benefit this location and allow for more tournaments to be held at this location.

The Clerk pointed out that it was very difficult to find a safe spot for the children's play area and that he and the Recreation Director would meet further with the Association to discuss their concerns.
