	Mrs. Bower made a presentation to the Commission updating them on the progress being made by the Scotia Pool Society. New members of the Board have been appointed and are very enthusiastic. Their long term goal is to keep Scotia Pool open after September, 2013. They hope to enhance the community not compete with the Rath Eastlink Community Centre. They are still interested to show that there will be enough patrons of the pool after Centennial Pool closes to make it a sustainable venture. The Scotia Pool Society is asking the Village of Bible Hill to consider including \$20,000 to \$30,000 in their budget 2013-14 fiscal year for operational expenses of the pool.	

## Brendon Smithson, Bible Hill Parks and Recreation Director

Mr. Smithson gave the Commission additional information on the upgrades to be done this summer at the Recreation Park. Several new items are being installed at the Recreation Park including new playground equipment, a new gazebo, a splash pad, and washroom facilities. The location of these items has been changed slightly and the Commission was asked their opinion of the changes. After questions and answers, he was given permission to continue the process of installing these items. The Clerk informed the Commission that there may be a need to be security cameras installed and also a security guard available to close the washrooms at night.

The Recreation Director has been approached by the Bible Hill RCMP to work on a joint project. The RCMP would like to team with the Village to engage youth in a project to paint the rocks in the parking lot at the Recreation Park. This idea will hopefully cut down on vandalism and make the community "take ownership" of the park. Applications of designs will be accepted and the successful artists will be given eco-friendly paint to create their masterpieces. The rocks will be pressure washed and cleaned before the painting begins. The Commission thought this was a wonderful idea and the Recreation Director was encouraged to begin this project.
