#### Councilor report- Blair

Councilor Blair reported on upcoming issues with the dangerous and unsightly premises within the Village. Colchester County is waiting on the increase cost of the RCMP for the 2016/2017 budget. The Council has also decided to have two budget meetings in April when the new County CAO arrives. The County and the Town of Truro has had a presentation from RECC on the 1.2 million dollar deficit for the 2015/2016 year. The County and Town will both contribute \$600,000 each but are currently looking into finalizing a cap to the RECC contributions.

### **New Business**

#### Review of February 2016 Financial Statements

The Clerk reviewed the February financial statements for the Village of Bible Hill. The Village revenues are on track with a slight increase due to the Natural Playground Grant. Expenditures are also on budget.

## 2016/2017 Budget and Tax Rate Approval

The Clerk suggested the commission approve the 2016/2017 budget and tax rate, the Clerk is awaiting property assessment information from the County but the budget tax revenue is based on a 1.2% increase. If the increase is more this amount will be placed in the Village reserve account.

## 2016-2017 Meeting Schedule

### Ditching Project- Village Line to Meadowland

Councilor Blair confirmed that the contractor hired for the Village Line to Meadowland Ditching Project has been terminated. The Clerk will be discussing options with the County Engineer for this project.

#### Sidewalk Meadowland- water problem

The Clerk has a solution for the water problem on the Meadowland sidewalk. He has been speaking to the property owner adjacent to Meadowland Rink to install a small catch basin in behind the sidewalk and tie it into the storm drain system. The Clerk is obtaining a quote from Will Kare for this work and will work on a letter to the property owner for the install of the catch basin near/on the property.

### Symposium on Municipal Structure

The commissioners were unavailable to attend the symposium on municipal structure.

#### Canada 150 Mosaic

The Clerk reported that Government of Canada is celebrating 150 years by building a Mural Mosaic including all provinces and territories over 80,000 painting and 150 individual murals that

once united will form a gigantic mural mosaic. Each province/territory will have 5-15 individual communities who will be selected to represent the province. An 8X8 Community Mural is \$12,500 and requires up to 400 participants. The commission agreed that we were unable to participate in this project, as we do not have the resources.
