Business Arising out of the Minutes

**Commission in Committee Report** 

Moved by McLean Seconded by MacCormick

*"I move that the Village of Bible Hill, due to increased projected expenditures due to Guest Drive Storm Sewer Project and the Pictou Road Sidewalk Project that the 2012-2013 budget be amended as follows:* 

- *a transfer from capital reserves to the operating fund of \$123,450*
- reduction of the staff social program by \$1,000
- elimination of the UNSM conference budget \$1,200
- *increase of the school crossing guard program budget from \$45,300 to \$50,200; for additional crossing guard at East Court and College*
- reduction of the sidewalk maintenance budget by \$30,000 to \$10,000
- elimination of the active transportation signage budget \$1,000
- reduction of the programming and special events budget by \$15,000
- elimination of the transfer to capital reserve \$72,250
- elimination of the security system at 67 and 69 Pictou Road \$40,000
- elimination of the office equipment budget \$10,000
- reduction of parks and recreation capital budget from \$13,000 to \$5,000
- reduction of the public works capital budget from \$5,000 to \$2,000
- increase in the Pictou Road sidewalk budget from \$350,000 to \$450,000
- increase in the Guest Drive Storm Drainage budget from \$750,000 to \$950,000

• the net effect is to increase the operating and capital budgets from \$2,857,000 to \$2,980,450"

"whereas the projected final costs of the Guest Drive Storm Sewer Project is \$200,000 over budget and the projected cost of the Pictou Road sidewalk project is \$100,000 over budget and that the Village of Bible Hill has just approved budget cuts totaling over \$150,000, I move that the Village of Bible Hill not incur additional expenses resulting from the takeover of Scotia Pool from the period of November, 2012 to September 2013."

Motion died on the floor due to lack of a seconder.

*"I move that the Village of Bible Hill have their Parks and Recreation Director apply for appropriate grants through the Community Infrastructure Improvement Fund to assist with the construction of gazebo at the Recreation Park for the Village's 60<sup>th</sup> Anniversary, washrooms at the Recreation Park, and a splash pad for the Recreation Park for the fiscal year 2013-2014."*

Commissioner MacCormick clarified that the proposed gazebo would be a multi-use structure that would enhance the Recreation Park. A grant was being used to cover half of the cost of this structure.

*"I move that the Village of Bible Hill accept the quote from Truro Tree Care for \$2,093 including HST, to remove 2 trees at 69* 

Pictou Road."

## 60 Anniversary Committee

Commissioner MacCormick reported on progress being made for the 2013 Bible Hill 60<sup>th</sup> Anniversary Celebrations. The next meeting of this committee will be Monday, September 17<sup>th</sup> at 2:00pm. An issue with regards to copyright laws will be reviewed by the Village Solicitor.

Review of Correspondence Speed Zone Assessment College Road

The Clerk read a letter from Rob Jerrott, District Supervisor, Nova Scotia Transportation and Infrastructure Renewal as an information item. Mr. Jerrott said that the speed zone assessment on College Road had been conducted as requested. It was concluded that the 60km/hr speed limit is appropriate.

## Reports of Commissioners Environmental Services Report

Commissioner McLean reported on the completion of the Storm Sewer Project at the Bible Hill Recreation Park. The project budget was \$750,000, currently there is a projected deficit of \$200,000.

## Protective Services Report & Fire Brigade Report

Commissioner MacCormick read a letter from MCW Maricor Engineering regarding the installation of a platform lift at the Bible Hill Fire Hall to make the second floor accessible to disabled fire brigade and fire brigade auxiliary members. In the opinion of the engineers:

- The width of the stairwell is insufficient to accommodate a folding platform style of travelling lift when it is in the open position.
- The landing at the bottom of the stairs is too small to accommodate the platform in the folded, parked position.
- There is nowhere in the existing stairwell that is wide enough to accommodate the platform in the folded, parked position.

To remedy the above limitations, it would be necessary to completely rebuild the existing stairwell or to build an entirely new one elsewhere in the building. Even ignoring the considerable impact to the neighboring spaces, since the stairwell is masonry (and possibly load bearing), a substantial amount of construction would be necessary. It is likely that the cost of renovating the stairwell to accommodate a platform lift would exceed the cost of providing a standard vertical lift. Given these constraints, it is our opinion that installing an inclined platform lift is not feasible.

Commissioner MacCormick also read the Fire Chief's report and told of events she had attended on behalf of the Village.

## **Recreation Services Report**

Commissioner McLeod read the Recreation Services Report highlighting a partnership with the NSCC Recreation Leadership Program to run after school programs, the success of the Bible Hill Day Camps, Summer Special Events, and additional After School Funding that was recently announced.

## **Transportation Services Report**

In Deputy Chair Van Kroonenburg's absence, the Clerk advised the Commission that due to the reduction in the sidewalk repair budget, patching would be done this year instead of major repairs.

## Chair's Report

The Chair reported on the events that he attended on behalf of the Village.
